Studio Policies

Water Bottles

We have a filtered water fountain available, so dancers may get a drink without bringing a water bottle. Students attending multiple classes are welcome to bring a water bottle, but please make sure it is **sealed and clearly labeled**.

No Food Policy

To help keep our studio clean, food is not permitted inside the building. Tables and chairs are available on our patio where dancers may enjoy snacks between classes.

Drop-Off & Pick-Up

For the safety of our dancers and our neighboring businesses, **please do not park or wait along the curb**. Our car line has blocked stop signs and created unsafe conditions for both traffic and children.

Please park in one of our available parking spaces and walk to the front door to pick up your child from their teacher. We appreciate your cooperation in helping us keep everyone safe!

Lobby Use

Our lobby is reserved for **students only**. It serves as a safe space for socializing, relaxing between classes, and completing homework.

Parents are always welcome to visit the Front Desk if you have questions, but we ask that you do not remain in the lobby during classes.

Class Preparation

Please ensure dancers arrive dressed and ready for class with:

- Proper dance shoes
- Hair securely pulled back
- Appropriate dance attire

Street clothes, school uniforms, dresses, and skirts are not permitted in class and a student will be asked to sit out.

If you have not yet purchased the correct shoe color, your dancer may wear the shoes they currently have until it's time to replace them. The correct shoe color will be required for Recital.
